Business of the year presentation to East Burke Rentals:

Al and Robin cannot be here tonight. In response to receiving the award, the Beaupre's said, "We are so very grateful to the Chamber, community and supporting businesses that honored East Burke Rentals with this nomination of 2025 Business of the Year! We "thank you" for the recognition and really appreciate it."

Guest Speakers:

Jon Schaefer – Burke Mountain/Bear Den Partners: This was 5 years in the making and can't wait to work with all the businesses.

Mike Pieciak - Vermont State Treasurer: Emphasized that expanding housing is a major priority, with money being invested into communities. He also highlighted the Baby Bonds initiative, designed to reduce intergenerational poverty, strengthen rural economies, and encourage young Vermonters to stay in the state. His proposal would invest \$3,200 for every child born on Medicaid, with the funds growing to an estimated \$11,500 by age 18 and \$24,500 by age 30. Beneficiaries would be required to live in Vermont when they withdraw the funds.

Shawn Tester, CEO of Northeastern Vermont Regional Hospital, discussed the rising cost of health care and highlighted NVRH's new construction project, which will include 25 beds dedicated to mental health services. He also noted that NVRH has formed a partnership with North Country Hospital.
